The forms you complete are kept in a secure place for 7 years for insurance purposes. I do not copy data from your forms into other electronic formats.

You may, of course, decline to submit your email and phone number to Emerald Holistics, which in some cases may mean that I am not be able to provide certain services to you.

If you do not wish to submit your email, and therefore are unable to book online, you can book your session or class by contacting me on 07720 845005.

I may, from time to time, use your phone number or e-mail to contact you about urgent class or appointment changes or to inform you if a waiting list place has become available. I will only do this if you have booked the class in question, or added yourself to the waiting list.
